- 1. Complete this application form and mail, email, fax or deliver to the Chief Election Officer, #1 Opal Drive, PO Box 190, Logan Lake, BC, VoK 1Wo, fax: 250 523-6678, email: <u>lgrimm@loganlake.ca</u>.
- If your application is complete and received between November 6 and November 21 at 4:00pm, the Chief Election Officer will prepare a mail ballot package for pick up or if time permits, mail to an address provided. If we receive your application after November 15<sup>th</sup> the time may be insufficient for mailing and receipt of the ballot; we recommend that you arrange to pick up your mail ballot package from the municipal office.
- 3. You are responsible for ensuring that your completed ballot is received by the Chief Election Officer **by General Voting Day, Saturday, November 23, 2024,** no later than 8 pm, close of voting.

<ul> <li>18 years of age or older on November 23, 2024 and</li> <li>a Canadian citizen; and</li> <li>a resident of the District of Logan Lake OR a non-resident registered owner of real property in the District of Logan Lake for at least the past 30 days; and</li> <li>a resident of BC for at least the past 6 months immediately before the day of voter registration; and</li> <li>not disqualified by law from voting in an election or otherwise disqualified by law.</li> </ul>
