The home based business shall be carried out wholly within a dwelling or permitted accessory building. 						
	4. No retail sales other than the sale of goods produced on the premises is permitted.5. Up to one (1) person, in addition to family members residing in the dwelling, may be engaged in the home business.						
	 6. The home based business shall not occupy more than 50 m2 of the dwelling and accessory building. 7. The home based business shall not occupy more than 25% of the gross floor area of the dwelling. 8. A home based business may not include: 						
	a) Stables, kennels or animal breeding operations;						
	 b) Restaurants: c) Parking or storage of commercial, industrial or construction equipment and material; d) Vehicle or equipment repair and maintenance; e) Metal fabricating; 						
	 No commercial vehicles exceeding 4,500 kg licensed gross vehicle weight are permitted to be parked or stored on the parcel unless completely enclosed within a building. 						
	 A maximum of one commercial vehicle used for the home based business is permitted on the parcel unler completely enclosed in a building. 						
	11. A person operating a home based business shall possess a District of Logan Lake Business License.
