**2022 Property Tax Reminder  
Due Date: July 4, 2022**

Municipal Hall remains open to the public to assist with the collection of tax payments. To reduce in-person and cash transactions, the District of Logan Lake is encouraging property owners to pay online through your financial institution or drop off your cheque through our secure Drop Box located at the main entrance of Municipal Hall.

All Home Owner Grant Applications **must** be submitted directly to the BC Provincial Government through a secure online application. Homeowners can apply online at [www.gov.bc.ca/homeownergrant](http://www.gov.bc.ca/homeownergrant) or you can call the contact centre toll-free at 1-888-355-2700 to use their self-serve system or talk with a live agent. Municipalities are **no longer** accepting Home Owner Grant Applications.

Be sure to make your payment and apply for your Home Owner Grant before the property tax due date of July 4, 2022 to avoid a late payment penalty of 10%.

**Regular Council Meeting Highlights**

**June 7, 2022**

1. Council awarded the paving tender of Jasper to Peter's Bros Construction Ltd. in the amount of \$438,091 (excluding GST);
2. Council approved that Staff prepare a report on paving overlay costs for that portion of the road at the campground located between the Visitor Centre and the Meadow Creek Golf Course; and that this be proposed to be included in the original scope;
3. Council approved the submission of the District multi-use court project to the Canada Community Building Fund - Strategic Priority Fund for \$350,000;
4. Council gave first, second, and third reading to the District of Logan Lake Election Procedures Amendment Bylaw 891, 2022; and Council appointed Laurel Grimm CEO; Sherry Verheyen DCEO with the following election remuneration rates for 2022: CEO \$1,200; DCEO \$900; Election Official \$600;
5. Council approved the late Grant-in-Kind Request from the Logan Lake Wellness, Health and Youth Society (WHY) in the amount of \$7,000 to operate the Discovery Camp at the Recreation Centre; and that Service Agreement between the District of Logan Lake and the WHY be amended to include the use of municipal facilities for events and programs which benefit the community upon prior approval of the Chief Administrative Officer;

1. Council approved that a meeting be requested with the Ministry of Jobs, Economic Recovery and Innovation at the Union of BC Municipalities Convention to discuss connectivity;
2. Council approved the 2021 Annual Report as presented;
3. Council gave third reading and adoption to Zoning Amendment Bylaw No. 889, 2022;
4. Council adopted Business Licence and Regulation Amendment Bylaw No. 888, 2022;
5. Council adopted Revitalization Tax Exemption Program Amendment Bylaw No. 890, 2022;
6. Council adopt Election Procedures Amendment Bylaw 891, 2022.

### 2023 Permissive Property Tax Exemptions

The District of Logan Lake will be accepting applications from non-profit organizations and places of worship that own land or improvements and qualify for a tax exemption under the requirements of the Community Charter and Council Policy.

Permissive Tax Exemption applications have been mailed to all organizations that were exempt from property taxation in 2022. Application forms including the Council Policy and the applicable sections of the Community Charter are available at the Municipal Office, 1 Opal Drive, Logan Lake, BC V0K 1W0.

Completed applications and supporting documentation for permissive tax exemptions in 2023 must be received by the Finance Department on or before July 29, 2022 to be considered for inclusion in the Annual Permissive Tax Exemption Bylaw.
