BYLAW NO. 709, 2012

A Bylaw to establish fees for services.

WHEREAS Section 194 of the Community Charter authorizes a local government, by bylaw, to impose fees and charges for all or parts of a service of the municipality;

AND WHEREAS Council deems it necessary to establish fees for specific services;

NOW THEREFORE the Council of the District of Logan Lake, in open meeting assembled enacts as follows:

1. This Bylaw may be cited for all purposes as the "District of Logan Lake Fees for Services Bylaw No. 709, 2012".
2. A fee of \$20.00 is imposed for persons other than the owner of real property, requesting a Property Tax Certificate for a specified real property, as per Schedule "A" which is attached to and forms a part of this bylaw.
3. A fee of \$20.00 is imposed for persons other than the owner of real property, requesting a Confirmation of Building Inspection Services and/or Violations pertaining to a specified real property, as per Schedule "B" which is attached to and forms a part of this bylaw.
4. A fee of \$.25 per single sided page is established for photo copies of District documents.
5. A flat fee of \$20.00 is established for photo copies of the District's Official Community Plan Bylaw with applicable maps, Zoning Bylaw with applicable maps and any documents that exceed 40 double sided pages.
6. District of Logan Lake Tax Certificate Bylaw No. 624, 2007 is hereby repealed in its entirety.
7. This Bylaw shall come into full force and effect upon adoption.
